


Business Description

Facephi Biometria SA is engaged in developing and marketing face recognition software and mobile biometrics technology. The company's software is used in online banking, mobile banking, social networks, ATM's, single sign-on and automotive sector. Its product offerings include SDK, Selphi, Me and PhiVox. The Company's main activity consists of marketing and implementation of biometric facial recognition software. The company derives majority of the revenue d from the sale of the rights to use (licensing, maintenance and support) of the recognition technology software by facial biometrics.

Valuation ^Qas of 26 Sep 2024

Morningstar affirms a 3-star quantitative rating for Facephi Biometria. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 1.55, a discount of 44.43% to its Quantitative Fair Value estimate of 2.79. This discount has ranged between 45.78% and 16.41% over the past year. The stock's price to fair value ratio is at the 28th percentile in our global equity coverage universe for this methodology and at the 24th percentile relative to its peers in the technology sector.

Facephi Biometria furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating dates to after 11/01/2023, before which it was 4-star. Similarly, the firm's uncertainty rating changed from Extreme to Very High after 08/26/2024.

We examine the financials and market statistics for Facephi Biometria to determine these ratings. Its earnings yield is -13.16% and its trailing 12-month maximum drawdown is 40.15%. These fall at the 21st and 67th percentiles in the equity universe and at the 21st and 59th in the technology sector,

respectively.

Quantitatively, we do not believe Facephi Biometria has an economic moat. Its moat score of 0.42 corresponds to the 44th percentile in the technology sector. Furthermore, this rating last differed from its previous rating of Narrow on 02/13/2024, when the company's moat score fell from its maximum of 0.85 (score of 1 indicates greatest economic moat). The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 33rd percentile in both the universe and sector. Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and enterprise value-tomarket value ratio. The book value yield is 57.24%, sitting at the 67th percentile in the technology sector. The company's enterprise value-to-market value ratio is 1.26, corresponding to the 68th percentile in the equity coverage universe and the

81st percentile in the sector.

Facephi Biometria reports losses per share of -0.2. Its return on invested capital is -12.61%. These values are calculated over a trailing 12-month period.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. i. **Quantitative Fair Value Estimate:** Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10% Medium – the interquartile range for possible fair values is less than 15% but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak – assigned when Quantitative Financial Health < 0.2

Strong - assigned when Quantitative Financial Health > 0.7

i. Last Close – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation**– Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

Undervalued – Last Price is below Morningstar's quantitative fair value estimate.
